- **SIX sets** of stamped, signed and dated site plans, printed at 24" x 36" if possible, or at a minimum 11" x 17", showing all dimensions, distances from property lines and roadways, lot coverage, means of ingress/egress, water source, septic, elevations, erosion control, etc.

- Steep Slope Permit Application, if applicable
(Review the Steep Slope Local Law, including the Permit Application and Review Process, section 707.6.1)
- UDML Permit Application, if applicable (for docks, moorings, boathouses, boat slips)
- Application fee of \$100 (make check payable to "Town of Middlesex")

Submit the above documents to the Code Enforcement Office. Printed maps must be delivered in person; all other documents may be submitted either in person or digitally to code@middlesexny.org AND codeclerk@middlesexny.org.

****All submissions are due three weeks prior to the Planning Board meeting date, which is the first Wednesday of each month.****
